Facility Fee: \$10/exhibitor- (exception will be a youth who is doing showmanship only and using someone else's animal. If they bring their own animals, they are expected to pay the facility fee and a penning fee.)

Show Order: The order of the show is subject to change!

Entries will be submitted entirely online using the Showman APP! You will also pay through this app as well. To Avoid late charges, entry fees must be paid online when entries are submitted unless prior arrangements have been made. NO REFUNDS!

Registration and Recordation Certificates:

Only goats registered with ADGA, AGS or CGS are eligible to compete. Those goats who have applied for registration with the above organization may also compete.
A registration/recordation certificate or the stamped duplicate showing the date received by ADGA office is required for any animal.

3: Stamped duplicate rules will follow the latest ADGA standard.

4: No copies of the registration/recordation certificate or the stamped duplicate application shall be accepted by show officials.

5: The document specified above as the requirement of the animal of that age to be shown must have been presented to the entry coordinator before judging begins.

6: Proof of ownership shall be the name on the registration /recordation certificate or the stamped duplicate.

7: Information obtained from the ADGA office via telephone, telegram, etc. shall not be accepted in lieu of the documents specified above.

Health requirements: Wyoming requires that all out of state animals be accompanied by a valid CVI. Further information can be found at the Wyoming state livestock board website. Diseased or injured animals will be removed from the fairgrounds upon recommendation of the show committee. Animals deemed unworthy of competition by the show committee may be barred from competition and removed from the grounds as well.

ALL GOATS MUST BE DEHORNED OR NATURALLY POLLED

Milk out at your own discretion-over uddered does will be discriminated against.

Bedding and feed: Bring your own bedding and feed.

There is a Tractor Supply Company and Bomgaars located on east Richards St. in Douglas if you need additional feed, bedding or other items. Douglas Feed and Ron's Supply is also available. **Penning:** pens must be pre-reserved and will be assigned. Pens are 6x4x4. All animals must be penned on the fairgrounds. The show committee reserves the right to limit the amount of tack stalls and excessive penning requests in the event the barn nears capacity. Exhibitors will be notified if that becomes an issue.
